#### Memorandum of Understanding for Skill Training

This Memorandum of Understanding is executed between the Representative, **Vedanta Foundation, Marine Lines, Mumbai** and the Representative **Mula Education Society, Ahmednagar Maharashtra** for arranging Basic Tailoring and Beautician courses, under Vedanta Skill Training Program, to underprivileged individuals at **Mula Education Society's Arts, Commerce and Science College, Sonai, Taluka: Newasa, Dist. Ahmednagar, Maharashtra 414 105.**

**Roles & Responsibilities-Vedanta Foundation.**

1. To provide required 10 number of Tailoring Machines (Black Head with Stands) required for the training as listed in **Annexure-II**. To utilize the existing Beautician Lab facility available with the Mula Education in the said premises and VF will provide the required consumables for the course
2. To provide well trained faculty/ Teacher for the center as per requirement.
3. To monitor the training program.
4. To conduct Assessment and provide Vedanta Certification to successful candidates.
5. To incorporate name and logo of the associating partner in the promotional material for respective centers.

**Roles & Responsibilities of the Mula Education Society:**

1. To provide Space for training centre free of cost (Two classrooms of min. 250 sq. ft. each. Per location)
2. To facilitate mobilization of minimum 300 students collectively for both the courses (150 Students per Course) per annum.
3. To provide the list of enrolled students in advance with the first installment for 50 students @ Rs.1600 per student @ course – 2 Module amounting to Rs. 80,000/- to Vedanta Foundation.
4. Advance payment cheque details:

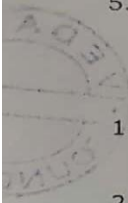

5. To provide basic facilities such as Water, Toilet facility for the center free of cost.

**Terms & Conditions:**

1. The MOU will be valid for the period of 1 Year from the date of signing the same.
2. All the assets will remain under the ownership of 'Vedanta Foundation' and it reserves the right to remove the same after the completion of the batch or expiry of MoU period whichever is earlier.
3. The Centre shall charge a Course Fees as mentioned in the Annexure-I.
4. The actual fees Payment to Vedanta Foundation will be based on No. of Students Enrolled for the courses. The fees amount payable in the last quarter will be adjusted accordingly.
5. The centre will appoint the faculty who is approved by the Foundation.
6. The centre will follow the approved holidays and allow only the approved and eligible holidays to the faculty without hindering the classes.
7. Attendance of the students as mentioned in the list submitted is mandatory and the maximum time allowed for joining the batch will be 1 Week from the

batch start day. The students who fail to join the batch within a week of batch start will not be allowed to join the batch. The fees of such students will be forfeited and there will be no claim from the associate for any kind of refund for such forfeited amount.

8. In the event of centre not able to provide the targeted students, the foundation may take a decision to close the centre after the tenure of the latest batch. In that event, the advance paid for the next batch fee will be adjusted against the logistics cost and the balance will be refunded to the centre
9. Vedanta Foundation also reserves the right to take back the Hardware provided and call off the association in the situation of the terms & conditions of this MoU are not adhered to and the compensation for the loss of time, energy and recourses shall be imposed on the associating organization.
10. At the end of the MoU time line, the centre should hand over all the assets installed / given by the foundation are to be returned and all dues to be closed 21 days prior to end of MoU time line.
11. In case of any disputes arising out of the circumstances irrespective of whether or not covered in the MoU should be resolved mutually.



## About the Programme

### Tailoring & Beautician Program

Much has been said than done about Livelihood for women in India. Vedanta Foundation through its project Vedanta Sakhi aims to facilitate the critical concern of livelihood among the deprived women population in the country.

Nation wide network of centres extends support to the livelihood skill seeking women. The objective of these centres is to empower the women population especially from the deprived backgrounds with effective professional skills leading to appropriate livelihood opportunities.

These centres provide appropriate skill development training programmes in the high demand services such as Tailoring and Beautician. Both the services are not only high in demand but also offer time flexibility on one hand and the option to operate out of home on the other , most suitable for the support seeking women population.

The courses offered in Tailoring & Beautician, typically range anywhere between 3 – 6 months, providing the students adequate knowledge to facilitate livelihood opportunities at the end of the training programme.

Technically sound trainers help and motivate the students to understand the smallest but critical technical know how of the desired skill development programme. The students are also provided tips on kick starting their livelihood through self employment opportunities.

The foundation boasts of successfully training and providing livelihood opportunities to more than 1 Lac women across the country since its time of inception in the year 1997.

Going forward, Vedanta Foundation shall further strengthen its support to the women population for appropriate livelihood by maximizing its reach across the country as well as enhance the professional knowledge among the skilled livelihood seeking students.

A lot has been done for women empowerment in India since we achieved independence, but Indian women still have a long way to go if we want to call ourselves empowered.

India has seen a powerful woman prime minister and women chief ministers of the states. But the truth is that women are still helpless in Indian society. Many women are still living below the poverty line, have no access to education facilities, have minimum lifestyle and have zero financial independence.

The reasons for zero financial independence are many but the most important being the lack of skills and time constraints due to the traditional responsibility of household chores (e.g., cooking, fetching water, and looking after children) entrusted on the Indian women.

Vedanta Sakhi is a reflection of the company's deep rooted belief in "equal partnership" among men & women in all aspects. Initiated in the year 1997, the project provides a platform for creating sustainable livelihood for the women population through appropriate livelihood skills training. The project is designed especially for those women who are compelled to live below poverty line due to tough circumstances of life.

Vedanta Foundation aims to support the cause of livelihood among the needy women population of the country by empowering them with skills offering livelihood opportunities.

The Foundation has aptly setup Sakhi training centres across the country to reach out to the needy women seeking a platform for developing skills offering them to livelihood opportunities. The Sakhi centres offers training in skills such as Tailoring, & Beautician keeping in mind the weak education background of the targeted women. The Sakhi centres are professionally run in terms of its operations and the course delivery. The students of the Sakhi centres undergo a rigorous skill training on the above mentioned skills for a period of anywhere between 3 months to 1 year based on the level of skill course/program enrolled for. The students undergo an examination at the end of the scheduled training and are awarded a Certificate based on the evaluation on successful completion of the training.

The Sakhi students are provided the know how of the various livelihood opportunities (employment / self employment) including tips for becoming a successful entrepreneur, post their certification.

The Foundation boasts of empowering and providing livelihood opportunities to more than 1 Lac women across the country since the project inception.
