The college is governed by College Development Committee (CDC). All major academic and administrative decisions are taken after discussion in the CDC. The college has been reaccredited by National Assessment and Accreditation Council (NAAC) in 2017 with ‘A’ grade. The College has been certified by ISO 9001:2015 for its quality policies and work ethics. The Department of Botany, Chemistry & Geography have been supported under star college scheme by Department of Biotechnology (DBT), Govt. of India. The college has been recognized as “Higher Education Review Top 10 Arts and Commerce Colleges – 2019” by Higher Education Review. The Institution has established Institution’s Innovation Council (IIC) as per the norms of Innovation Cell, Ministry of HRD, Government of India, during the academic year 2018-19 (ID No. IC 201811682; Certificate No: 1305).The Ministry of Education, Govt. of India has conferred 4 Star Status to the college for its IIC (Institution’s Innovation Council) Activities.



As per the census of the current academic year, 2021-22, there are 79 full time faculty (53 male and 26 female) working in the institution. Out of them 29 are permanent faculty and 50 are temporary faculty. In all there are five Professors, five Associate Professors and rest of them are Assistant Professors. In the current academic year there are 2110 students have been enrolled in the institution out of them 1593 are UG students, 485 PG students and 32 Ph. D. scholars. Out of 2110 total students, 1237 are boys and 873 are girls. Among these students 158 belong to SC, 40 to ST, 634 to OBC, 776 to Open and 502 to other categories (NT A/B/C/, Minorities, SBC, etc.). There are 40 non-teaching staff (39 male and 01 female) in the institution.

Reservations Policy:

Fee Structure:

Fees for all degree programs are charged as per the rules and directives of Savitribai Phule Pune University (Savitribai Phule Pune University Ref. No. PGS/676 dated 28.02.2020). The annual fees must be paid in advance at the time of admission and at the beginning of each year. The fee structure is subject to change at any stage as prescribed by the Savitribai Phule Pune University and Government of Maharashtra.

Cancellation of Admission and Refund of Fees

Cancellation of Admission and Refund of Fees are strictly as per the rules and regulations of Parent University.

Examinations:

As per the rules of Savitribai Phule Pune University, Choice Based Credit is followed in all academic programs offered by the college. Semester pattern of examinations are followed for all UG and PG programs. Students are evaluated by both external and internal evaluation systems. External evaluation is done by the university and it amounts to 70%. Internal evaluation is carried out by the college and it amounts to 30%. Continuous Internal Evaluation (CIE) pattern is followed in conduction of internal evaluation.

Code of conduct:

Students are required to take note of the following and to adhere to the requirements:



i) Campus Discipline and Conductive Environment

Students should comply with the ordinance of 157 of Savitribai Phule Pune University, regarding maintenance of Discipline and good conduct.

ii) Classroom Attendance

The College runs full time programmes and requires the students to attend classroom sessions regularly. As per the rules of Savitribai Phule Pune University, students should have at least a minimum of 75% attendance to complete the programme. Absenting from the classroom and indulging in any non-academic pursuit during the scheduled lecture time is considered an offence and will invite disciplinary action against the student.

iii) Wearing of Identity Cards

While on the College Campus the student must compulsorily wear their Identity Cards and must produce the same when any staff member of the College asks for identification. They are also required for borrowing books from the library.

iv) Dress Code:

The students should strictly observe the dress code while attending the college.

v) Stand against Ragging

It has 'zero tolerance' towards ragging. Ragging within the institution or out of it is strictly prohibited.
